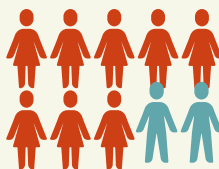

We have a digital audience (email + social media) of 45,000 people in Florida. Of those, 80% are women, 20% are men.

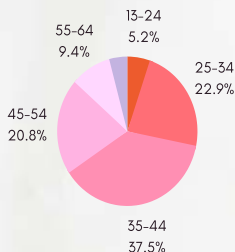


OUT OF HOME REACH

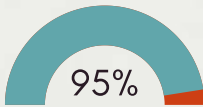

Over 70% of our adult responders indicated they have attained a bachelor's or graduate degree.

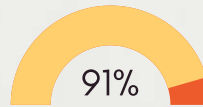
PARENT PEER GROUPS

90 parents received training on brain development, media, social norms, and parent peer groups. Median score increased from 80% (before training) to 95% (after training).

230 adults received training about Rx drug misuse. Median score increased from 73% (before training) to 91% (after training).

Lock Your Meds - Vaping Training

340 students receiving training about Rx drug misuse and the dangers of vaping. Median score increased from 43% (before training) to 86% (after training)



Alcohol Literacy Challenge

Don't let marketing/mass media control your children. Be an Informed Family:

- Know age appropriate behaviors for your children.
- Set appropriate guidelines for your children.
- Monitor your children's behavior online and with friends.
- Model appropriate behavior.
- Participate in your children's school and daily life.

Participate in our Prevention Campaigns:

Family Day (September) – A day to eat dinner together as a family that promotes parent/child engagement.



“Since Family Day started at our school, families have been more engaged with the school community and have a better understanding of how important family time is. We have been hearing more stories about how parents are helping with homework, spending more time understanding curriculum and volunteering on campus. Additionally, our students are more engaged and more aware of the dangers of drug and alcohol abuse.” – Michele Meservey, Educator

Red Ribbon Campaign (October 23-31) – Substance abuse prevention campaign to engage parents, schools and the community.

“Alcohol and drugs are really hard topics to bring up in schools and often administration and parents do not want to address the issue. I cannot express enough how instrumental campaigns such as Red Ribbon Week can be in the lives of students.” – Morgan McNally, M.Ed. in Counseling, School Counseling



Lock Your Meds (January-February) – Prescription drug abuse prevention awareness.



“Inside the home, a child should never have a choice to use prescription drugs that have been left unlocked and locking these medications up takes that choice out of the children/teens hands. Thank you so much for making all of us more aware of the tragedy that can await a family from inside the medicine cabinet through your Lock Your Meds campaign.” – Laura Allen-Tummon, Mom

Safe Homes Smart Parties (March-May) – Graduation and prom safety campaign to help parents set guidelines and protect teens.

“My husband had to identify the body of our daughter, Helen Marie, at the scene of the drug and alcohol-related crash that killed her. I don’t want that to have to happen to anyone. In order to protect our kids, the message needs to be clear. The alcohol industry spends billions getting their message out and our message needs to be just a strong.” – Helen Witty, Mom

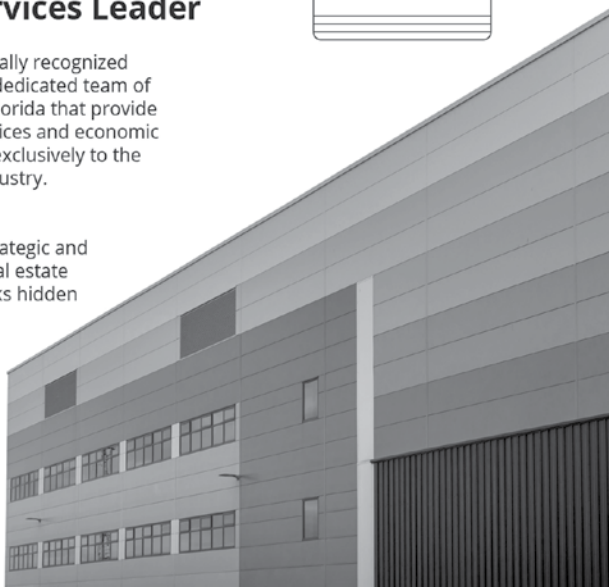
